3. Description of the processing operation

3.1. Area of activity in which the processing is carried out

The EEA is creating a leadership competency framework for all its leaders that describes the desirable behaviours across hierarchical level, the areas of expertise, cultural background and so on.

For the purpose of this project, EEA wishes to provide an effective and efficient assessment of leaders' preferences on the basis of a Leadership Orientations Questionnaire (LOQ). This is an online psychometric tool designed specifically for leadership assessment provided by the company Kenexa. The LOQ assesses an individual's natural preference (or capacity) for leadership and what motivates them for high performance, using two online questionnaires. The diagnostic helps identify whether an individual has a technical or general leadership preference which will be beneficial for the individual but also for the EEA in order to identify relevant career paths for each person.

The tool has an approximate completion time of 30-40 minutes and is available online. Following completion, individual developmental feedback and reports are provided. These describe the individual leaders' preference in various domains that can be mapped to the EEA competency framework.

The High Performance Motivations Questionnaire (HPMQ) is an online self-report questionnaire that assesses an individual's underpinning motivations which drive the long-term goals which

people have in the world of work. The tool has an approximate completion time of 20-30 minutes and is delivered online. A combined individual report is provided for each individual with the outcomes of both the LOQ and HPMQ assessments.

In addition, a group report will be provided which will reflect the total leadership team's current areas of strength, against the requirements of the EEA competency framework and external benchmarks for high performing leaders, as well as identifying potential areas of risk where particular competencies are under-represented.

Following the delivery of the individual reports, it is foreseen to follow-up with supportive coaching session to aid the interested leader in understanding their report, it's relevance to their performance and possible responses or courses of action which may be appropriate for them and their careers.

⊠ Automated processing (please describe)		The data subject will enter his/her personal data directly in the online tool. The individual responses to the questionnaires will then be assessed and benchmarked on the basis of the methodology developed by the external service provider Kenexa.

4. Lawfulness and purpose of the processing

2.2 Modalities for the processing operation

4.1. Legal basis

Master Agreement entered into between the EEA and Kenexa an IBM Company on 9.1.2014.

There is no restriction under Article 20 of Regulation (EC) No 45/2001. The processing operation is not subject to Article 27 of Regulation (EC) No 45/2001.

4.2. Grounds for lawfulness

The data processing is considered lawful because:

- it is necessary for the performance and the support of a task carried out in the public interest on the basis of Regulation (EC) No 401/2009 or in the legitimate exercise of official authority vested in the EEA (Article 5(a) of Regulation (EC) No 45/2001, and
- the data subject has unambiguously given his or her consent (Article 5(d) of Regulation (EC) No 45/2001).

4.3. Purpose of the processing

As described under 4.1 above.

Each data subject may choose to use the recommendations specified in the individual developmental feedback report to feed into his/her career development cycle (CDC).

5. Features of the processing operation

5.1. Categories of data subjects concerned

Staff members currently employed at the EEA holding a management function as Head of Programme or Head of Group or holding an advisory function as Senior Adviser.

5.2. Categories of data

Basic administrative data related to the staff member such as his/her name, function (Head of Programme/Head of Group/Senior advicer), email address

Information and data entered by the staff member in response to the questionnaires (LOQ, HPMQ).

6. Retention practice of personal data

The personal data will be retained for the duration of the EEA Master Agreement with Kenexa (i.e. a period of maximum 6 months which may not exceed 30.6.2014). Upon completion of the agreement, the data will be destroyed.
